JOB PURPOSE
<ul style="list-style-type: none"> To ensure the safety and wellbeing of users and visitors to the facility and smooth running of operations via lifeguard duties, cleaning duties and reception duties. To assist the pool operator (HSE publication – Managing health and safety in swimming pools (HSG 179)) to meet the duty of care and compiling with industry guidance and the law.

MAIN DUTIES AND RESPONSIBILITIES
<ul style="list-style-type: none"> To ensure tasks are completed as required in accordance with the Normal Operating Procedures (NOP) and Emergency Action Plan (EAP) as set out in the Pool Safety Operating Procedures (PSOP).
<ul style="list-style-type: none"> To provide trained assistance to pool users in difficulty and provide first aid/resuscitation if appropriate.
<ul style="list-style-type: none"> To assist in monitoring water quality within the pools.
<ul style="list-style-type: none"> To intervene and prevent accidents by early intervention.
<ul style="list-style-type: none"> To undertake cleaning to areas of the facility as directed.
<ul style="list-style-type: none"> To undertake all reception duties; dealing with basic Customer enquiries either in person or by phone, booking of swimming lessons, stocking of saleable stock, stocking of vending machines, completing end of day cashing up paperwork, and keeping the reception area clean, adhering to admission policy.
<ul style="list-style-type: none"> To be accountable for all monies received whilst on reception duty.
<ul style="list-style-type: none"> To ensure all saleable stock is accounted for whilst on reception duty.
<ul style="list-style-type: none"> Carrying out tasks to assist other departments within Folkestone & Hythe District Council if the pool is closed.
<ul style="list-style-type: none"> Being vigilant whilst on duty – adhering to the 10:20 scanning system whilst observing the pools as taught on NPLQ course.
